- A. COMDT COGARD WASHINGTON DC 261721Z SEP 22/ALCOAST 359/22
- 1. This ALCOAST announces changes to REF (A).
- 2. Changes to REF (A) include:
- a. The authorization of SDP for AST Instructors in paragraph 4.is updated to eliminate the limitation to ATTC and is replaced with:
- "Aviation Survival Technician (AST) Instructors*.....SD-2 ATTCAST"
- b. The authorization of SDP for PSU Tactical Coxswain in paragraph 4. is updated to eliminate the limitation to active duty members and is replaced with:
- "PSU Tactical Coxswain*.....SD-1 COXPSU"
- c. The authorization of SDP for IDFSO in paragraph 4 is updated to correct the eligible cutter classes and is replaced with:

"Independent Duty Food Service Officer (IDFSO)*

Cutters Classes: WLM, WLIC, WLI, WLR, WTGB, WPB, WPC....SD-3 IDFSO"

d. The authorization of SDP for FSO in paragraph 4 is updated to correct the eligible cutter classes and is replaced with:

"Food Service Officer (FSO)*:

Cutter Classes: WLB, WAGB, WLBB, WMSL, WMSM, WMEC, WIX..SD-3 FSO"

e. The list of SDP authorizations in paragraph 4 is updated to include:

"Precision Marksman-Aviation (PM-A) HITRON/ATC*......SD-2 APMARK"

- f. Paragraph 5.a. is replaced with: "Aviation Survival Technician (AST) Instructors: Members assigned as AST "A" School Instructors at TRACEN Petaluma or ATTC who are fully qualified as an instructor by TRACEN Petaluma or ATTC CO. Instructors must maintain currency qualifications in order to maintain SDP eligibility. SDP stops upon lapse of qualifications or qualification currency."
- g. Paragraph 5.p. is replaced with: "Independent Duty Food Service Officer (IDFSO) assigned to cutter classes WLM, WLIC, WLI, WLR, WTGB, WPB, & WPC: CS personnel assigned to an eligible cutter class, designated as the FSO, and utilizing the Purchases vs Allowance Inventory (PVA) system IAW COMDTINST 4061.5, are authorized SDP effective 01 OCT 2022 or upon report date, whichever is later. The member must acquire the CS-17 competency code within one year of authorized SDP date. If the member does not acquire the CS-17 competency code within one year of authorized SDP date, SDP will be suspended until the CS-17 competency code is authorized by the CS Rating Force Master Chief."
- h. Paragraph 5.q. is replaced with: "Food Service Officer (FSO) assigned to cutter classes WLB, WAGB, WLBB, WMSL, WMSM, WMEC & WIX: CS personnel assigned to an eligible cutter class, designated as the FSO, and utilizing the Perpetual Inventory (PI) system IAW COMDTINST 4061.5, are authorized SDP effective 01 OCT 2022 or upon report date, whichever is later. The member must acquire the CS-18 competency code within one year of authorized SDP date. If the member does not acquire the CS-18 competency code within one year of authorized SDP date, SDP will be suspended until the CS-18 competency code is authorized by the CS Rating Force Master Chief."
- i. Paragraph 5.dd. is replaced with: "PSU Tactical Coxswain:

Tactical Coxswains must be assigned to a PSU and routinely serve in the unit's rotational watch schedule as a certified operational Tactical Coxswain. Members must complete Tactical PQS, and be certified by the CO as a Tactical COXN. Tactical Coxswains augmenting a PSU must be on Title 10 Orders (10 USC 12302 or 10 USC 12301(d)) in support of a contingency, and deployed with a PSU, in order to qualify for SDP."

- j. The following is added as paragraph 5.kk.: "Precision

 Marksman-Aviation (PM-A) HITRON/ATC*: Member must be assigned to a

 deployable billet, designated in writing by the unit CO, and fully
 qualified."
- 3. All other provisions of REF (A) remain in effect.
