


CWO Personal Data Extract

Introduction This guide provides the procedures for for a Chief Warrant Officer (CWO) to print their Personal Data Extract (PDE).

Information All PDE’s are updated prior to each CWO Appointment cycle and are only viewable for a specified timeframe. Review the message for deadlines for PDE verifications and corrections.

5	<p>Points/Dates/Times:</p> <ul style="list-style-type: none"> • Sea Duty Qualified: Y=Yes, N=No An entry of Yes or NO indicates if the member has met the sea duty eligibility requirement for the CWO Appointment Board. Candidates must have completed at least one year of sea duty as an E-6 or above by the 1 January deadline. This requirement will not be waived except for members who are presently serving at sea or who are under orders to sea duty and will meet the sea duty requirement by 30 June following the Board’s convening date. • AD Base Date – The date you entered active duty, or your adjusted ADBD from a Statement of Creditable Service (SOCS) following a break in service. • Time in Service (TIS) – The time in all branches of service up to the Terminal Eligibility Date (TED). • Marks Factor – The final marks multiple. • E6 Pt(s) – The time in grade calculated in months up until 1 July of the year of the CWO Appointment Board. One point is credited for each full month of active service as an E-6. The maximum credit for E-6 is 100 points. • E7 – E9 Pt(s) – The time in grade calculated in months up until 1 July of the year of the CWO Appointment Board. Two points is credited for each full month of active service as an E-7 or above.
