- Marriage certificate

- Insurance policies (life, home, vehicles, etc.)

## Your loved ones will need to have access to these documents (cont):

- Income tax records (past three years)
- Documents referring to bank accounts, loans, securities, etc.
- References to safe deposit boxes
- References to outstanding debt
- Vehicle title and registration

Funeral planners or family members of eligible deceased veterans may request funeral honors by contacting a representative at the number listed in the Military Funeral Honors Directory for their area.
