'JBJ: HEALTH, SAFETY, AND WORK-LIFE SERVICE CENTER (HSWL SC) ESTABLISHMENT A. OPERATING FACILITY CHANGE ORDER (OFCO) NO. 040-10: RE-NAME AND CHANGE THE REPORTING CHAIN OF THE HEALTH, SAFETY, AND WORK-LIFE SUPPORT ACTIVITY (HSWL SUPACT).

- 1. THE PROVISIONS OF REF (A) HAVE BEEN ACCOMPLISHED.
- 2. EFFECTIVE 29 AUG 10 THE HSWL SUPACT IS RENAMED HSWL SC AND REPORTS TO CG-11. THIS COMMAND AT IOC IN 2009 WAS COMPRISED OF THE MLC(K) DIVISIONS, AND THE CLINIC AND WORK-LIFE STAFFS PREVIOUSLY ASSIGNED AT ISC, HSC, ATC, YARD, CGA AND TRACEN COMMANDS. REF A NOW CHOPS ALL OTHER LOCATIONS WITH PRIVILEGED PROVIDERS (MEDICAL OFFICERS AND DENTAL OFFICERS) TO THE OPERATIONAL CONTROL AND TECHNICAL AUTHORITY OF HSWL SC. THESE OPERATIONS FALL UNDER HSWL SC IN ORDER TO PROVIDE HEALTH, SAFETY AND WORK-LIFE SUPPORT. AIRSTA AND SECTOR CLINICS ARE NOW REQUIRED TO FUNCTION AS PART OF THE ASSIGNED PRODUCT LINE ORGANIZATION (FIELD OFFICE PRACTICE), RESPONSIVE TO THE HSWL SC PRODUCT LINE MANAGER (PREVIOUSLY FIELD OFFICE SUPERVISOR) AND THE HSWL SC TECHNICAL/PROFESSIONAL CHAIN OF OVERSIGHT. THE LOCAL COMMANDS RETAIN THE CONTROL OF LOCAL AND NON-TECHNICAL ISSUES THAT DO NOT IMPACT THE DELIVERY OF HSWL SERVICES. PAL CONFIGURATION CONTROL OF HSWL RELATED POSITIONS IS A SERVICE CENTER FUNCTION.
- 3. DETACHED HEALTH, SAFETY AND WORK-LIFE SERVICE CENTER ELEMENTS, PRODUCT LINES (PL) WILL FUNCTION WITHIN AND SUPPORT EACH DISTRICT AOR, THE NATIONAL CAPITAL AREA, THE CG ACADEMY, TRACEN CAPE MAY AND THE PUERTO RICO AOR. A HSWL PL IS A FORWARDLY PLACED UNIT OF THE HSWL SC ENSURING AND COORDINATING ACCESS TO AND/OR DELIVERY OF HEALTH, SAFETY, AND WORK-LIFE SERVICES TO NON-DEPLOYED COAST GUARD MEMBERS AND EMPLOYEES AND PROVIDING DIRECT PROGRAM OVERSIGHT AND SUPPORT TO DEPLOYED INDEPENDENT DUTY HEALTH SERVICES TECHNICIANS. A HSWL PRODUCT LINE MANAGER (PLM), A COAST GUARD OFFICER WITH HEALTH CARE ADMINISTRATION TRAINING AND EXPERIENCE, LEADS EACH HSWL PL (EXCEPT ACCESSION CENTERS), FUNCTIONING AS THE GROUP PRACTICE MANAGER. THE LARGE MISSION SPECIFIC HSWL PL AT THE CG ACCESSION POINTS (CG ACADEMY AND TRACEN CAPE MAY) WILL HAVE USPHS O-6 MEDICAL OFFICERS AS DIRECTORS INSTEAD OF HSWL PLM AND WILL BE SUPPORTED BY A CLINIC ADMINISTRATOR.
- 4. HSWL SC HAS PLACED DETACHED DUTY STAFF ELEMENTS IN BOTH AREA COMMANDS. A SENIOR CHIEF HEALTH SERVICE TECHNICIAN IS ASSIGNED AS DETACHED DUTY TO THESE ORGANIZATIONS TO PROVIDE DAY-TO-DAY SUBJECT MATTER EXPERTISE AND MOVE ISSUES BETWEEN THE SUPPORTED COMMAND AND THE HSWL SC ORGANIZATION.
- 5. HSWL SC HAS ASSIGNED, ON A DETACHED DUTY BASIS TO FORCE READINESS COMMAND A USPHS O-6 SAFETY AND ENVIRONMENTAL HEALTH OFFICER AND A GS-0018-13 SAFETY MANAGER.
- 6. HSWL SC HAS ASSIGNED IN WRITING, ON A COLLATERAL DUTY BASIS, TO EACH AREA AND EACH DISTRICT COMMANDER, A MEDICAL OFFICER TO SERVE AS THE COMMAND SURGEON TO MANAGE DISTRICT-LEVEL FLIGHT SURGEON COVERAGE AND PROVIDE COUNSEL AND ADVICE REGARDING OPERATIONAL MEDICINE ISSUES.
