A MEB HAS BEEN INITIATED WHEN A COAST GUARD MEDICAL OFFICER (OR HIGHER AUTHORITY AS DESCRIBED IN CHAPTER 3 OF REFERENCE (A)) QUESTIONS THE MEMBERS FITNESS FOR CONTINUED DUTY DUE TO APPARENT PHYSICAL OR MENTAL IMPAIRMENT(S) AND DIRECTS THAT A MEB BE CONVENED TO CONDUCT A THOROUGH EXAMINATION OF THE MEMBERS PHYSICAL OR MENTAL IMPAIRMENT(S).
- 4. ONCE THE MEB DATE HAS BEEN ENTERED INTO MRRS, THE MEMBERS INDIVIDUAL MEDICAL READINESS METRIC AND THE DLC METRIC WILL TURN RED IN THE COAST GUARD BUSINESS INTELLIGENCE (CGBI) SYSTEM.
 5. COMMANDER (PSC-PSD-DE) WILL ENTER THE DATE THE BOARD WAS CLOSED WHEN THE MEB HAS RECEIVED THE REQUIRED PROCESSING THROUGH THE PHYSICAL DISABILITY EVALUATION SYSTEM.
