

Foreign Military Sales: SFLC Directly Supports Efforts In Ukraine By Michael Ciaglo



In March, 2016, USCGC DRUMMOND was decommissioned at the Coast Guard Yard in Baltimore, and in March, 2017, USCGC CUSHING followed. These 110 WPBs were identified as candidates for Excess Defense Article (EDA) transfer, the process by which assets determined to be excess to the US Government are offered to foreign nations. This effort, led by the Department of State, allocated these two hulls to the Government of Ukraine for use by their Navy in 2017. With this identification, the EDA process began and led to an ongoing effort over the last six years resulting in a total of seven 110 WPBs transferred to the Ukraine Navy.

CG-922, the Office of International Acquisitions, is the HQ office responsible for executing EDA cases for the Coast Guard. Once the case was approved, the first step was to perform a Joint Visual Inspection with the UAN, which took place in Baltimore in July, 2017. Representatives from the country flew over and met with CG-922 and the Surface Acquisitions Logistics Center's Cutter Transition Division (CTD) to discuss the timeline and cost of the case as well as inspect the decommissioned cutters. This was followed by a Work Definition Conference (WDC) in June, 2018 in Kyiv where details were finalized, including the cost estimate, drydock availability worklist and timeline for start of vessel reactivation. We hope that everyone was able to strike a proper work-life balance this summer, and spend quality time with family and friends.

I would like to highlight some of the Assignment Year 2023 transfers within CG-45. In CG-453, CAPT Pat Lineberry assumed command of the Aviation Logistics Center, the first honorary Naval Engineer to serve in this capacity; CAPT Malcolm Belt reported in from NED Charleston; and LCDR Ryun Konze departed to serve as CGC HEALY'S EO. In CG-451, LCDR Elise Ross, our LRE Systems Manager, transferred to Honolulu and was replaced by LCDR Kyle Ennis who is reporting in from Grad School at Purdue; LT Kevin O'Brien, our ISVS/POLAR System Manager, departed the CG and was replaced by LT Josh Gumbleton from CGC BERTHOLF. In CG-452, LCDR Mike Langelier, our Industrial Resource Manager, departed to serve as CGC POLAR STAR's EO and was replaced by Industry Training graduate LCDR Greg Bredariol. In CG-459, LCDR Phil Rodino departed to serve as the Sector Upper Mississippi River Logistics Dept Head and was replaced by LT Avery Fanning who is reporting in from Grad School at Michigan. Just as we are seeing

across our service, several billets in CG-45 have been gapped due to service-wide workforce shortages.

Mission support continues to evolve and advance the Commandant's and Deputy Commandant for Mission Support's vision of a highly integrated, efficient, and operationally effective support system. Across the CG-4 spectrum of mission support elements, we are actively working towards aligning the lines of effort between the logistics centers and unlocking synergies.

In August, CAPT Lineberry and I hosted a workshop at the Aviation Logistics Center with 20 active duty and civilian personnel from the Aviation and Surface Forces Logistics Centers to strengthen communications and synchronize mission support delivery through increased collaboration at the staff level. In September, CG-41 invited me to speak at the Student Aeronautical Engineer (AEN-10) indoctrination course, which marks the official start of their professional development syllabus. We discussed what the Aviation and Surface fleets have accomplished through collaboration, information exchanges and standardization of business process and logistics elements across CG-4. My takeaway from both of these events was – our problems are universal and the pathway to advancing mission support is through increased collaboration across our logistics centers.

Mission support continues to innovate and advance policies and processes. In July, we supported the Office of Cutter Forces update to the Safe To Sail Commandant Instruction, which for the first time made it a requirement for Shipboard Automation and Control Systems to be operational to safely operate a cutter. SFLC's Data Analysis Team has leveraged the engineering data extracted from the 154' WPC propulsion system to modify maintenance intervals and increase reliability. CG-453 is partnering with NAVSEA to enroll the 418' WMSL fleet into the Navy's CBM+ "Healthy Engine" program for the main gas turbine, which will unlock digital twin capabilities. These actions are quickly laying the framework for us to unlock the next generation of Condition Based Maintenance opportunities that will decrease maintenance actions, increase reliability, and better inform our maintenance and supply forecasting systems.

Lastly, and most importantly, I want to thank you for taking the time to recognize the accomplishments of our workforce. Across the Naval Engineering Awards portfolio (Poore, Perry Afloat/Ashore, Stabile, and Lucas Afloat/Ashore), we received 43 nominations, nearly double the amount submitted in previous years.

In September, 2018, ex-CUSHING and ex-DRUMMOND were formally transferred to Ukraine in a signing ceremony at Coast Guard Yard attended by then-Ukrainian President Poroshenko. Following a few more months of finalizing details, these two hulls began their drydock availabilities at Coast Guard Yard in January, 2019. The work included blasting and painting of the hulls (to navy grey!), removal and replacement of two main diesel engines and two ship's service diesel generators for overhaul, and reactivation of all machinery systems following the two-year layup at the Yard. This effort lasted until July, running to a total of \$3.5M along with multiple spare parts purchased from PBPL stock, at which point the hulls were ready for training. The newly-christened hulls SLOVYANSK (P190) and STAROBILSK (P191) were moved to the Yard's West Wall where CTD trained 36 Ukrainian sailors how to operate and perform basic maintenance on their newest patrol boats. After 12 weeks of classroom and hands-on training, all the sailors graduated the course and returned to Ukraine while the vessels were prepared for shipment to Odesa by a US-flagged heavy lift ship. The ships were finally delivered to their new homeport in October, 2019.

In the meantime, the Ukrainian Navy was approved for further transfers of 110 WPBs, and was allocated the soon-to-be decommissioned OCRACOKE, KISKA and WASHINGTON, the latter two needing to be moved from Guam to Baltimore. Following their decommissioning in 2019 and 2020, they were formally transferred to Ukraine and a similar effort to the first pair was undertaken. All three hulls were drydocked at the Coast Guard Yard, blasted, painted, and had all systems reactivated in order to prep the ships for crew training and final shipment to Odesa. This effort was significantly greater than for the first pair due to conditions of the hulls, and industrial work at Coast Guard Yard ran through the summer of 2021, and the first two, FASTIV and SUMY (ex-OCRACOKE and ex-WASHINGTON) were shipped to Odesa in November, 2021. KUBRAK (ex-KISKA) remained at the Yard finishing the drydock and was scheduled for shipment in February, 2022, however, this last vessel has remained in a caretaker status in Baltimore due to the Russian invasion of Ukraine.

In August 2021, Ukraine was again allocated two more 110 WPBs, identified as EDISTO and NANTUCKET. This case was approved in October, 2021 and the vessels officially transferred in April, 2022.

It was with great sadness that we learned in March, 2022 that SLOVYANSK was lost in action in the Black Sea following a Russian missile strike. 11 souls were lost, most of whom were trained here in Baltimore by CTD.

100 Years Ago 1923, Aerial shot of the Depot (Yard)



During the 1920's, production of boats, canvas work, and numerous other articles for the needs of the Service was stepped up. Extensive overhauls and repairs were performed on the then-modern vessels YAMACRAW, SENECA, SEMINOLE and many 100', 125' and 175' patrol boats and tugs. The 500 personnel of the Depot (Yard) included civilian employees along with enlisted personnel. The Depot had gained a

nationwide reputation for the fine quality of its work. Its small boats were famed throughout the world, wherever life-saving stations were located or cutters patrolled the seas.

By the 1930's, many of the original buildings and equipment at the Depot had become outdated. Funds were obtained through Congressional appropriations to modernize the plant. A new boat, gas engine and machine shops were constructed and equipped; a 40-ton marine engine railway was installed. With the transfer of the Lighthouse Service of the Department of Commerce to the Coast Guard in 1939, buoy construction became another major Depot function.
