STRONG QA KEEPS LREPL EFFICIENT AND SAFE By LT Amanda Roy

Aloha, from beautiful Honolulu, Hawaii! I am LT Amanda Roy, the Quality Assurance Branch Chief for Long Range Enforcer Product Line (LREPL) in Honolulu Hawaii. I lead a five person staff comprised of one CWO and four E7/E8s of multiple rates, in conducting quality assurance for depot level repair work onboard WMSLs, primarily MIDGETT and KIMBALL homeported in Hawaii, Most recently, we completed KIMBALL Drydock FY23, a \$19M planned availability at Pacific Shipyard International, which included preservation of the freeboard, superstructure, and underwater body, as well as propulsion and rudder repair work. This contract also included an engineering change for a transom door modification that extended the height of the doors by 5ft and increased the rate which the doors open and close. Prior to the availability, the doors took almost 5 minutes to open or close. After the availability the doors open or close in under 30 seconds. This is a huge benefit to the WMSL fleet which has experienced overtoppings of the doors while underway swamping small boat assets staged in the notch as the ready boat. The speed of the doors opening and closing is also a huge improvement to crew safety; small boat crews must wait in the boat as the doors open and close and therefore must be ready to maneuver in case of a wave event through the doors. Now, with the increased speed, the crew is protected from waves, and the cutter can navigate off boat launch courses much sooner. (continued on page 6)

CG-45's CORNER

Hello from HQ and the Office of Naval Engineering! We hope that everyone was able to enjoy this festive holiday season and spend quality time with family and friends.

As 2023 comes to a close, CG-45 has been reflecting on the noteworthy accomplishments across the Naval Engineering Community from fielding new surface assets to advances in workforce initiatives.

People: It's no secret that there is a workforce shortage across the Coast Guard, with some specialties and ratings experiencing higher than average vacancies. CG-452 has been a stalwart advocate for our workforce and an absolute trailblazer on numerous lines of effort.

• Critical Skills Billet/Temp Promotion: The Commandant's vision to increase flexibility for management of the officer corps has resulted in the establishment of a Critical Skills Billet Pilot Program. Naval Engineering has been designated as a critical skillset and CG-45 will continue to leverage this program to the advantage of our service and our members. In AY23 one Naval Engineering position filled under this program received a temporary promotion to the next higher rank. In AY24 at least one Naval Engineering position will be filled under this program with a temporarily promoted officer.

- Major Cutter Engineering Technician (MCET) Program: AY24 will include the rollout of this new MCET Program for MKs, EMs, and DCs in the E4 and E5 paygrades to support WMEC-270 and WMSL-418 engineering through a 3-part structured assignment program that includes two tours afloat and one tour at the co-located Maintenance Augmentation Team (MAT).
- NavEng Industry Training Program: We are now in the third full year of the Naval Engineering Industry Training Program. In the first two years, we embedded Coast Guard officers in Amazon to gain an understanding of their operations, engineering, and talent management processes. In AY23 we partnered with Ford Motor Company to increase our understanding of how system maintenance, engineering changes, and quality assurance are conducted in a large-scale, high-paced, for-profit, environment.
- 2-4-2 Structured Assignment Program: The 2-4-2 Program has been approved for a third consecutive year with a \$100K incentive bonus for obligating 8 years of active duty service. We've seen huge officer corps benefits, such as an increase in application rates for O3 EO positions, and professional work experience shaping to ensure success in our critical O4 EO positions. The tour length for O3 EOs in 2-4-2 is only 2-years, which has increased the total number of O3 EO opportunities. Operations Afloat has recently received approval to commence a similar 2-4-2 program for their community in AY24.

Leadership: Continuous improvement and effective communications have been, and will continue to be, the critical enablers to us growing our brand reputation and strengthening our partnerships. As a lifelong learner, I read about 1 leadership book a month and there isn't a month that goes by where I don't learn some leadership nugget, or two, that I wish I had learned 10-years ago. Under the umbrella of leading change and the voice of the customer, I want to share two recent books with you. If you choose to read the below books, please share with me your leadership takeaways as viewed through the lens of mission support. And if you have any book recommendations, please share.

- Leading Change: Switch: How to Change Things When Change Is Hard, by Chip Heath and Dan Heath. My biggest takeaway is that I was underestimating the importance of including emotions in a change management strategy when leading a change initiative.
- Voice of the Customer: Thanks for the Feedback, the Science and Art of Receiving Feedback Well, by Douglas Stone & Shelia Heen. My biggest takeaway was the importance of properly identifying and selecting feedback channels when giving and receiving feedback.

NEW YEAR HEALTY CONFLICT RESOLUTION

As 2023 ends and the New Year approaches, you may be contemplating resolutions and setting goals for self-improvement such as exercising more, balancing diet, or setting up a savings plan. However, perhaps you should consider how you could improve your leadership competencies, or more specifically your conflict resolutions skills? When you reflect on the SFLC command philosophy tenets — People, Performance, and Purpose — and CAPT Marcus Canady's December presentation on "The Art of Intrusive Leadership", it is apparent that self-awareness and the ability to improve how you come across and react to others is a common theme crucial for today's leaders to build relationships, inspire trust, and encourage others to promote

open communication. But as people become more comfortable and have more engaging discussions, there is also the inevitable need to understand, engage, and employ conflict resolution skills so that issues do not escalate.

Conflict Handling Styles

Recognizing your own actions and reactions is a start to mitigating conflict, but to successfully navigate issues in the workplace, you must first understand why conflicts arise and how you can apply different strategies to find an agreeable solution. Active listening and asking "why" help unveil the root of the issue while understanding your preferred style and

the impacts of employing that style help identify how to best approach specific situations or personality styles.

Because each conflict differs there is not a best way to resolve each issue; however, whatever the cause of the dispute, the steps for confronting conflict with respectful, productive conversations are the same. Consider the issue, identify the parties that need to be part of the conversation, and set ground rules for the discussion with the goal of resolution.

Identify Root of Conflict, Severity, and Appropriate Parties to address

Engage in direct, respectful, and honest discussion with necessary party toward goal of finding solution Set ground rules for a productive conversation, actively listen, beaware of and manage your reactions

Know when & who you should ask for help to mediate

Ultimately, while conflict is unavoidable, and not always negative, the failure to deal with it will impact your credibility as a leader, and could lead to decreased morale, degraded performance, or the creation of a hostile work environment. While these difficult conversations, may require you to step out of your comfort zone for a short period, remember the reward is for the greater good and long-term. As you develop your 2024 resolutions, ask yourself whether you are doing your part in managing and resolving conflict in the workplace!

LREPL is unique in that it is staffed to provide quality assurance (QA) personnel along with a Port Engineer (PE) to support the inport periods for our modernized assets, WMSLs and HEALY. The QA staff support all cutters at the pier in Honolulu, managing multiple contracted depot actions on one or both cutters. We take over the COR and inspector responsibilities freeing up the PE and cutter crew from those roles. Currently, my team is managing three contracts onboard KIMBALL, a Main Propulsion Diesel Engine 8,000 hour Overhaul, a Dockside availability, and a Fire Suppression System Maintenance contract, this totals almost \$5M in contracted work. The KIMBALL PE, LT Emily Kingsley, must manage the integration of the entire KIMBALL inport period; this ranges from the contracted dockside availability to a routine Maintenance Augumentation Team (MAT) Shoreside Maintenance Project, to working with the C5I PE to deconflict repair work, and also integration of cutter crew led projects. The QA staff has taken on the more task-heavy requirements, but for perspective this is only 3 of a total 15 depot level actions Emily is monitoring this inport period along with the cutter and C5I led requirements.

This is my fourth tour in the Coast Guard and it has been a change of pace since my first two units were operational. Upon graduating from the US Coast Guard Academy in 2017, as a Naval Architecture and Marine Engineering major, I reported to CGC STRATTON. While onboard STRATTON as a Student Engineer, I stood watch in main control and on the bridge. After two years, I fleeted up to fill the Assistant Engineer Officer billet for an additional 9 months. STRATTON set me up to then become Executive Officer of CGC OLIVER HENRY, which I commissioned and sailed 11,000 miles to our homeport of Santa Rita, Guam. After two years conducting boardings and search and rescue across Oceania, I reported in to SFLC Honolulu in 2022. I am tour complete this summer, July 2024, and have requested WMEC Engineer Officer billets in the Virginia area as my top picks, with CGC SENECA being my #1 choice! I am excited for my future assignment and to continue my career in both Operations Afloat and Naval Engineering.



SFLC BOOTS ON THE GROUND



My name is LT Alex Murdoch and I am currently stationed in Cape Canaveral, FL. I am one of nine Medium Endurance Cutter Product Line (MECPL) Port Engineers responsible for contract execution as Contracting Officer Representatives and acting as a boots on the ground for SFLC. The cutters that I support span between Pensacola, Mayport, and Cape Canaveral. When there are many projects occurring simultaneously, port engineers frequently travel outside their area of responsibility to cover availabilities for their assets and spread the workload amongst the section. I transferred to MECPL in July 2022 from CGC Kimball, where I was the Assistant Engineer Officer. The pace of work has required adjusting. I was on two cutters before this and the underway schedule, filled with hectic inports and never-ending work lists, was all I was used to. But on independent duty no one is looking over my shoulder and directing my to-do list. The down time between projects is perfect for working on certifications, attending professional classes (e.g. NACE/SSCP), and professional development in general. I have the freedom and purview to study what I need to be proficient as a Port Engineer while also pursuing other learning opportunities. I recently completed over 100 hours of online training for acquisition certifications and countless hours GRE studying.

On the other hand, during an active project I am drinking from the fire hose once again; working with contractors and overcoming hurdles to maximize the amount of repair work for the aging WMEC fleet. My first project was a dream! I had support from my fellow Florida Port Engineer, LT Joey O'Connell, an experienced EO to manage ship's force, competent contractors who exclusively work on Coast Guard assets, and it was at my homeport, Cape Canaveral. No added travel stress. It was an ideal combination of events for my first project. Fast-forward three months and two projects later, I show up at a Brooklyn dry dock and was responsible for closing out a project that had been delayed several times due to weather, contractor latency, and unexpected casualties. It was a very different experience. I was only successful because of the support of multiple colleagues and experts whom I had never met. Being geographically separated from Product Line and all my SFLC "coworkers" has had its complications. Every project is a unique environment with different questions and issues arising daily. Due to these challenges, I have relied on building working relationships through phone calls, emails, and constant communication during projects. It has been a rewarding experience the last several months with plenty to put in my ditty bag as a Coast Guard officer, both professionally and personally.
